

## Fall 2025 Tree Canopy Agreement

The Tree Canopy Program is a partnership between the City of Prospect and its homeowners to increase the tree canopy in Prospect. The City has funded 20 shade trees of 2" diameter for spring planting that will be available on a FIRST COME/FIRST SERVED basis. The program costs the homeowner \$175 payable to the City of Prospect, and includes the cost of the tree, a tree guard, mulch and professional installation of the tree. A back yard planting may result in a slightly higher planting fee depending on access. *Tree selection order and check need to be received at City Hall by September 19.*

Trees may not be planted within 10 feet of overhead utility, internet or cable lines, and should not be planted within 8 feet of a recent tree removal. Also, please avoid a planting location in low spots, drainage areas or in wooded areas. As a tree order has been accepted at City Hall, *the homeowner will be given a marking flag. The provided flag must be placed in the desired planting location by Nov. 1..* Professional tree planters hired by the city will contact B.U.D. (Before-You-Dig) to request that public utilities be marked. The site will be visited by a member of the Forestation Board, and a second flag noting location approval will be placed. If there is a site issue, the owner will be contacted to determine an alternate location. Trees will be planted in late November or early December, weather permitting.

### TREE CANOPY AGREEMENT

- ✓ I agree to waive any and all liability of the City of Prospect and the City's Forestation Board or their assigns for planting, care and future maintenance of the Homeowner's selected tree.
- ✓ I agree to pay the City of Prospect \$175 for the tree, tree guard, mulch and professional installation.
- ✓ I understand that there is no warranty on the tree.
- ✓ I agree that it is my responsibility to locate personal installations such as invisible fencing and irrigation systems.
- ✓ I am responsible for repair and expense of any damaged systems in the tree planting.
- ✓ I agree to place the provided flag in my selected tree location prior to the marking of utilities and during the time of planting. It is my responsibility to ensure that the flags are not removed by other service providers. NO FLAGS – NO TREE – NO REFUND
